Scope Threshold

(1) Has annual gross revenues > \$25 mil; (2) Annually buys, sells, or shares personal information of 100,000 or more consumers or households; or (3) Derives 50% or more annualrevenues from selling or sharing personal information

Control or process the personal data of: (1) at least 100,000 consumers in a calendar year or (2) at least 25,000 consumers and derive over 50 percent of gross revenue from the sale of personal data

Control or process the personal data of: (1) at least 100,000 consumers in a calendar year or (2) Derives revenue or receives a discount on the sale of personal data and processes or controls the personal data of 25,000 or more consumers
